Within Enhansment, Hans has worked for various clients in the field of IT and change in business services.

As an interim manager he has worked for NIBC, Stater and cegeka-dsa.

- He fulfilled the role of interim manager IT Retail (35 FTE) for NIBC in 2022. The most important change has been the shift in teams from application teams (core banking, Salesforce, data) to product teams (Mortgages, Savings, Buy to Let), which has improved business-IT alignment considerably.
- From the end of 2019, Hans was IT & change manager at Stater for two years. He was end responsible for the Digitization domain (13 teams, 130 FTE, € 10-15M in customer projects per year) and for the DIGI program (€ 5-10M per year). In IT terms, he was responsible for development and management of all portals and API;s, In addition, he was actively involved in developing a new Target Operating Model for Stater IT, a strategy that focuses more on product vision and agile working.
- In 2019, Hans was responsible for the project managers (10 FTE) and the management of the project portfolio (€ 5M per year) for cegeka-dsa (ERP software for housing corporations) as an interim manager. Participated on behalf of cegeka-dsa in steering groups in various ERP implementations.

As a change manager, Hans has worked for CMIS group, ABN AMRO and cegeka-dsa, among others.

- Hans led the Hyppo program for the CMIS group (mortgage servicing and advice). In a short time a new integrated servicing street was delivered (Davinci Close), as well as a new data warehouse (Power BI) and a completely new network architecture (Azure, Office 365).
- In 2015/2016 Hans successfully completed two critical issues for ABN AMRO as program manager. In the penalty interest task force, more than 10,000 customers were compensated in a short period of time for incorrectly calculated penalty interest. In the Interest change ('rentemiddelen') program, the interest change process online and STP has been realized for all ABN AMRO labels. In 2012, as a project manager, he realized the realization of a new front office application for ABN AMRO mortgage advisers.
- Hans led the SEPA program for cegeka-dsa in 2013/2014, in which more than 40 housing associations were made SEPA compliant within 6 months.

Hans also worked as a product manager at the National Mortgage Guarantee (NHG) between 2016 and 2018 and currently he works for NHG as a strategic policy advisor

- At NHG, he was responsible, among other things, for the development of the sustainability deposit (financing for energy-saving measures) and mortgage solutions for specific target groups (including seniors, temporary workers). In addition, he has played an active role within NHG in the realization of a more agile organization.
